TIMES AND ELIGIBILITY

TEST HOURS: 7:00 am until 5:00 pm

ROLL CALL: AM Test – 8:00am, PM Test – 1:00pm

INSPECTION: Immediately follows Roll Call, with early inspection available

ELIGIBLE BREEDS AND REGISTRY: Coursing Ability Tests are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS Program), individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program.

Dogs with breed disqualifications are eligible to enter.

Females in season may not enter.

A dog may enter only once per event.

COURSING ABILITY TEST

300 YARD COURSE: This distance is for dogs shorter than 12 inches at the withers or brachycephalic ("flat-faced") dogs. A dog must complete this course in less than 1½ minutes. Veteran dogs may run 200 yards. 600 YARD COURSE: This distance is used for all dogs that do not run the 300 yard course. A dog must complete this course in less than 2 minutes. Veteran dogs may run 400 yards.

RIBBONS:

Orange qualifying ribbons will be awarded to dogs passing their test. Title rosettes will be awarded to those dogs who obtain a coursing ability title upon passing their test.

PRE-ENTRIES and PAYMENTS: For pre-entry, please send check or money order made payable to "BDTC", to 2749 Ophelia Court, Simi Valley, CA 93063. It must be received prior to 8pm on Thursday September 7. EMAIL entries will be accepted provided payment is received before 8pm on September 7, 2017. Pre-entries are \$20 per dog per event. Day of entries will be accepted (\$25 per dog per event). Running order is generally determined by the order in which entries are received.

ENTRY INFORMATION:

- 1. No peanuts are allowed on school grounds due to allergies.
- 2. Dogs not present at the time of roll call will be scratched after a 5 minute grace period.
- 3. Each entry will be examined at inspection for soundness.
- 4. Bitches in season and/or lame dogs will be excused and have their entry fees refunded.
- 5. Spayed and neutered dogs may be entered.

OPERATIONAL INFORMATION: Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic bags. Backup equipment will be available.

GENERAL INFORMATION:

- Please bring your own food, shade and water.
- 2. A restroom will be available.
- 3. No one, except Field Committee members, will be allowed on the field without the express permission of the Field Committee.
- 4. A \$5 fine will be assessed for loose dogs during courses in progress.
- 5. Anyone failing to clean up after their dogs' waste will be excused from the field for the day.
- 6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.


Average High: 78° Average Low: 60°

Field Surface: Mowed school field grass Fencing: 100% enclosed by chain link

300 yards [Dogs shorter than 12 inches or brachycephalic ("flat faced") dogs], one loop.

600 yards [Dogs taller than 12 inches], both loops.

Veteran dogs (age 7 or older), need only run 2/3 of the course.



AKC Rules re Collars and Coursing Ability Tests (Chapter XV, Section 10):

"SECTION 10. COLLAR/PARAPHERNALIA. Dogs may wear any collar except a choker collar, a collar with prongs or an electronic training collar. The collar should be snug to minimize the chances of getting hung up on something during the run. Owners should be aware that there is a chance that tags hanging from the collar could become entangled on something during the run. Owners may use clips or rubber bands to hold the dog's hair. The owner assumes responsibility for the safety of the dog with regard to the dog's collar and paraphernalia on the dog."
