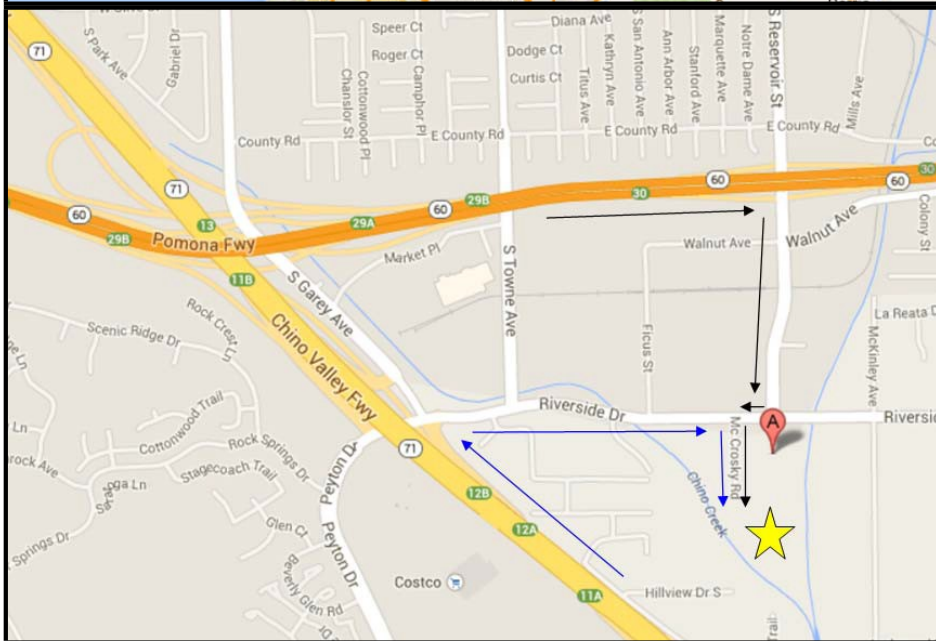
DIRECTIONS

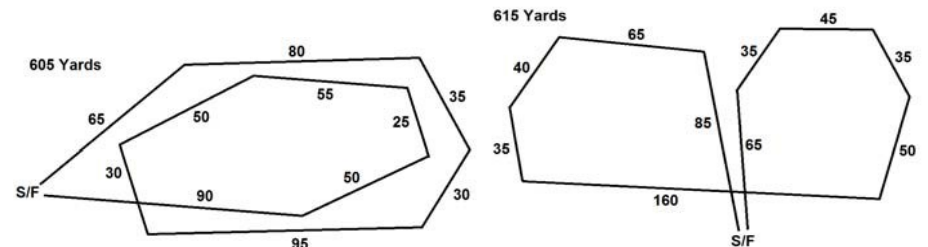
