**OPEN STAKE:** Open to Silken Windhounds excluding ASFA Field Champions of record that have met the certification requirements.

**SPECIAL STAKE:** Open to Silken Windhounds that have earned their ASFA Field Champion title.

**VETERAN STAKE:** Open to Silken Windhounds that have reached 6 years of age on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles.

**SINGLE STAKE:** Open to Silken Windhounds including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles. **Best in Field will not be offered.** 

<u>LURE COURSING INSTINCT STAKE</u>: Open to all non-sighthound breeds. All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS.
