#### TIMES AND ELIGIBILITY

TRIAL HOURS: 7:30 am until completion

ROLL CALL: AM event - 8:30 am; PM event - 1:00 pm

**INSPECTION:** Immediately follows Roll Calls with early Inspection available **ELIGIBLE BREEDS AND REGISTRY:** FastCAT events are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program.

Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event.

#### **EARLY ENTRY FEES AND PAYMENTS**

MAIL ENTRIES to the Field Secretary's address above with checks payable to "SCIHC". FAX ENTRIES will not be accepted. E-MAIL ENTIRES will be accepted provided the Field Secretary receives payment before 8:00 pm on Friday, August 2, 2019 and the entry form is signed.

#### FastCAT EVENT

Dogs run singularly in a timed 100-yard dash. The dog is released at the starting line by one person and must be caught by a second person at the finish line. These events are divided into 3 categories depending on the height of the dog. The height is used in the calculation with MPH to determine points awarded towards AKC FastCAT titles.

#### RIBBONS AND TROPHIES

> Light blue qualifying ribbons are awarded to dogs passing their test.

#### **ENTRY INFORMATION**

- 1. Dogs not present at the time of roll call will be scratched after a 5 minute grace period.
- 2. Each entry will be examined at inspection for soundness.
- 3. Bitches in season and lame dogs will be excused and have their entry fees refunded.
- 4. Spayed and neutered dogs may be entered.

## OPERATIONAL INFORMATION

- 1. Gas powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.
- 2. Electronic timers will be used. Backup manual timing will be available. Failure to follow instructions regarding release and catch may invalidate the time.
- 3. Dogs may start up to 10 feet behind the starting line.
- 4. It is recommended that the owner or someone familiar with the dog stand at the finish line in order to catch the dog once the dash has been completed.

#### **GENERAL INFORMATION**

- 1. Please bring your own food, shade and water.
- 2. A restroom will be available.
- 3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
- 4. A \$5 fine will be assessed for loose dogs during courses in progress.
- 5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
- 6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
- 7. SCIHC assumes no liability for injury to any person or dog before, during or after the events.

#### **POINTS CALCULATION**

- 1. The dog's time to complete the 100 yd dash is converted into MPH
- 2. A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:
  - a. 18" and over = 1.0 handicap
  - b. 12" to under 18" = 1.5 handicap
  - c. Under 12" = 2.0 handicap
- 3. Points = MPH multiplied by the dog's handicap
- 4. Fast CAT suffix titles are earned at designated milestones:
  - a. BCAT = 150 points
  - b. DCAT = 500 points
  - c. FCAT = 1,000 points
  - d. FCAT# = every additional 500 points

#### **VETERINARIAN**

Head south on Jamboree Road. Turn left onto Santiago Canyon Road and the merge onto the 241 North. Next, merge onto the 91 West. Take exit 39 for Weir Canyon Road/Yorba Linda Boulevard. Turn right onto Yorba Linda Blvd. Turn right onto Savi Ranch Parkway. Turn left onto Crystal Drive and the facility will be on the left.

#### HOSPITAL

Head south on Jamboree Road and turn right onto Santiago Canyon Road. Then, merge onto the 55 South. Next, merge on the 22 West. Take exit 15 for Main Street and turn left onto W La Veta Avenue. Turn right onto Pepper Street and the hospital will be on the right.

#### **CAMPING**

No overnight camping is permitted.



**From San Gabriel Valley:** Take the 57 South onto the 91 East. Next, merge onto the 55 South. Then, take the Chapman Avenue and turn left. Turn left onto Jamboree Road. Continue forward and the road will curve to the right for the park.
