ELIGIBLE BREEDS AND REGISTRY: Only purebred Silken Windhounds may enter. All entries shall be individually registered with the Silken Registry (ISWS), UKC,, an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

LURE COURSING TRIAL

OPEN STAKE: Open to any eligible Silken Windhound excluding ASFA Field Champions of record, that have met certification requirements.

FIELD CHAMPION STAKE: Open to Silken Windhound ASFA Field Champions.

VETERAN STAKE: Open to any eligible Silken Windhound whose age is over 6 years, on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles.

SINGLE STAKE: Open to any eligible Silken including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles. Hounds will run alone.

LURE COURSING INSTINCT STAKES: Open to all Non-Sighthounds and Sighthound mixes: **Small Open** for dogs 17 ½ inches or less at the withers and/or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC. **Small Senior:** for dogs 17 ½ inches or less at the withers or brachycephalic ("flat-faced") dogs who have achieved the title of LCC. **Small Veteran:** for dogs 17 ½ inches or less at the withers and/or brachycephalic dogs over the age of 7 years. **Large Open** for dogs over 17 ½ inches at the withers who have not achieved the title of LCC. **Large Senior:** is for dogs over 17 ½ inches at the withers who have achieved the title of LCC. **Large Veteran:** for dogs over 17 ½ inches at the withers who are over the age of 7 years. **Sighthound mix Open** for dogs with a sighthound breed in its background who have not achieved the title of LCC. **Sighthound mix Senior** for dogs with sighthound breed in its background who have achieved the title of LCC. **Sighthound mix Veteran** for dogs with sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

SOCAL CUP QUALIFYING EVENTS

For any hound that enters these trials, they will accumulate SoCal points based on the number of dogs defeated within a particular sighthound breed. The dogs defeated are calculated on cumulative score without regard to the stake entered (i.e. open, special, veteran). Of the 14 scheduled trials, your hound must have minimally competed in 8 of them to attain eligibility into the SoCal Cup final in December.

ENTRY INFORMATION

- 1. All entries must be one year or older on the day of the trial.
- 2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- 3. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at rollcall.
- 4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- 6. Hounds not present at the time of roll call will be scratched.
- 7. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- 8. Hound certification runs will be offered a half hour prior to rollcall.

OPERATIONAL INFORMATION

- Each course will be reversed for the final runs and reversed again for the Best of Breed run.
- 2. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

GENERAL INFORMATION

- 1. Please bring your own food, shade and water.
- 2. A restroom will be available.
- 3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
- 4. A \$5 fine will be assessed for loose hounds during courses in progress.







We will follow State and local guidelines.

- 1. All participant will wear facial coverings over nose and mouth and maintain social distancing of 6 feet.
- 2. Please bring your own food, water and shade for yourself and your dogs. None will be available at the trial.
- 3. We ask that you park 6 feet away from each other.
- 4. Roll Call will be done at everyone's car, instead of at the secretary's table area. The roll call committee will wear gloves and facial coverings. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
- 5. Wickets will be wiped down after each dog is measured.
- 6. We will have instant hand sanitizer and wet wipes in several locations for your use.
- 7. Restrooms: We must use the restroom at the kennel area where you check-in and pay to enter. Please keep in mind you will likely want to drive to this area as it is uphill from the field.
- 8. Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
- 9. Dogs will be run in braces to ensure social distancing at the line and will be 6 feet apart.
- 10. Practice social distancing the best you can. Please act responsibly.
- 11. We will be posting the draws and scores for each breed separately to allow for ease of social distancing, and will post them on the So Cal Coursing FB page.
