#### **ELIGIBLE BREEDS**

Only purebred Rhodesian Ridgebacks that are one year of age or older and have been registered with the American Kennel Club, an AKC recognized foreign registry or that have been granted a Purebred Alternative Listing (PAL/ILP) may be entered.

#### LURE COURSING TEST

JC TEST RUNS: Open to all eligible Rhodesian Ridgebacks. A hound, at least 12 months of age, running alone shall receive a certifications from a Judge on one date and a second certification from a different Judge at a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

QC TEST RUNS: Open to all eligible Rhodesian Ridgebacks. A hound at least 12 months of age (Qualifying Hound) running with another hound of the same breed or another breed with a similar running style (Partner Hound) shall receive certification from a licensed judge, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption. The handler presenting the Qualifying Hound shall be responsible for providing the Partner Hound for the test. It is recommended that every Qualifying Hound practice with other hounds prior to being presented for a QC test.

\*\*\* Hounds earning their QC at this event are not eligible to enter the specialty trial due to said entry being a conditional entry \*\*\*

(AKC Regulations for Lure Coursing Tests and Trials, Chapter III, Section 3, Item 6)

#### **LURE COURSING TRIAL**

#### **REGULAR STAKES OFFERED**

OPEN STAKE: Open to Rhodesian Ridgebacks that have obtained an AKC Qualified Courser Certificate, an ASFA Hound Certification, an ASFA Field Champion title, or a CKC Field Champion title. Rhodesian Ridgebacks that have earned an AKC Field Champion title are not eligible to enter the Open Stake.

SPECIAL STAKE: Open to Rhodesian Ridgebacks that have earned their AKC Field Champion title.

**OPEN VETERAN STAKE:** Open to Rhodesian Ridgebacks that are eligible to enter the Open or Special Stakes and have reached 7 years of age on the day of the trial. **SINGLE STAKE:** Open to Rhodesian Ridgebacks including those disqualified to run in other stakes.

#### **NON-REGULAR STAKES OFFERED**

**KENNEL STAKE:** For two Rhodesian Ridgebacks, designated at the time of entry, entered in one of the regular stakes, owned and kenneled by the same person. BREEDER STAKE: For two Rhodesian Ridgebacks, designated at the time of entry, entered in one of the regular stakes, bred by the same individual.

#### THE MANZANITA CUP CHALLENGE TROPHY

The Manzanita Cup Challenge Trophy honors "Gigi" MBIF DC Manzanita's Gorgeous Gaelic Gal CD MC LCX2 AX AXI FN RATM CGC VC. For permanent possession it is to be won three times by identical ownership (all persons), not necessarily with the same dog nor in consecutive years. The name of the winning dog will be suitably engraved on the trophy. The challenge trophy will remain in the custody of OCRRC until retired.

#### **ENTRY INFORMATION**

- 1. Hounds not present at the time of roll call will be scratched after a 5 minute grace period.
- 2. Each entry will be examined at inspection for breed disqualifications.
- 3. Bitches in season, hounds with breed disqualifications (except for the Single Stake) and lame hounds will be excused and have their entry fees refunded.
- Spayed and neutered hounds, without breed disqualifications, may be entered.
- 5. Monorchid and cryptorchid hounds are ineligible to participate.

#### OPERATIONAL INFORMATION

- 1. All hounds will run twice, in trios, if possible, or braces unless excused, dismissed or disqualified.
- 2. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
- 3. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

#### **GENERAL INFORMATION**

- 1. Please bring your own food, shade and water.
- 2. A restroom will be available.
- 3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
- 4. A \$5 fine will be assessed for loose hounds during courses in progress.
- 5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
- 6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
- OCRRC assumes no liability for injury to any person or dog before, during or after the Tests and Trials.



#### DIRECTIONS


**From Orange County:** Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From the Inland Empire: Take the 91 West onto the 71 North. Exit Butterfield Ranch Road/Euclid Avenue (CA-83) and make a right. The facility will be located on the right side 1/10 of a mile down Euclid Avenue.

**From San Gabriel Valley:** Take the 210 East to the 57 South. Then, transition on the 71 South towards Corona. Take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit and turn left. The facility will be located on the right side 1/3 of a mile down Euclid Avenue.

Take exit 39 for Weir Canyon Rd/Yorba Linda Blvd. Turn right onto Yorba Linda Blvd. Take the 1st right onto Savi Ranch Pkwy. Take the 1st left onto Crystal Dr.


#### **BEST IN HOUND CLASSIC**

CCA / OCRRC PROCEDURES We will follow State and local guidelines.

- 1. All participant will wear facial coverings over nose and mouth and maintain social distancing of 6 feet.
- 2. Please bring your own food, water and shade for yourself and your dogs. None will be available at the trial.
- 3. We ask that you park 6 feet away from each other.
- 4. Roll Call will be done at everyone's car, instead of at the secretary's table area. The roll call committee will wear gloves and facial coverings. We will ask the owners of females to wipe their own dogs and show the inspection committee the tissue.
- 5. Wickets will be wiped down after each dog is measured.
- 6. We will have instant hand sanitizer and wet wipes in several locations for your use.
- 7. Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
- 8. Dogs may be run in braces, at the discretion of the club, to ensure social distancing at the line and will be 6 feet apart.
- 9. Practice social distancing the best you can. Please act responsibly.
- 10. We will be posting the draws and scores for each breed separately to allow for ease of social distancing, and will post them on the So Cal Coursing FB page.
