Points and placements go towards the V-FCh and V-LCM titles. **SINGLE STAKE:** Open to any eligible sighthound breed including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles. 




