ELIGIBLE BREEDS

Only purebred Greyhouds that are one year of age or older and have been registered with the American Kennel Club, an AKC recognized foreign registry or that have been granted a Purebred Alternative Listing (PAL/ILP) may be entered.

LURE COURSING TRIAL

REGULAR STAKES OFFERED

OPEN STAKE: Open to Greyhounds that have obtained an AKC Qualified Courser Certificate, an ASFA Hound Certification, an ASFA Field Champion title, or a CKC Field Champion title. Greyhounds that have earned an AKC Field Champion title are not eligible to enter the Open Stake.

SPECIAL STAKE: Open to Greyhounds that have earned their AKC Field Champion title.

OPEN VETERAN STAKE: Open to Greyhounds that are eligible to enter the Open or Special Stakes and have reached 7 years of age on the day of the trial. SINGLES **STAKE:** Open to Greyhounds including those not eligible to run in other stakes.

ENTRY INFORMATION

- 1. Hounds not present at the time of roll call will be scratched after a 5 minute grace period.
- 2. Each entry will be examined at inspection for breed disqualifications.
- 3. Bitches in season, hounds with breed disqualifications (except for the Single Stake) and lame hounds will be excused and have their entry fees refunded.
- 4. Spayed and neutered hounds, without breed disqualifications, may be entered.
- 5. Monorchid and cryptorchid hounds are ineligible to participate.

OPERATIONAL INFORMATION

- 1. All hounds will run twice, in trios, if possible, or braces unless excused, dismissed or disqualified.
- 2. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
- 3. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

GENERAL INFORMATION


- 1. Please bring your own food, shade and water.
- 2. A restroom will be available.
- 3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
- 4. A \$5 fine will be assessed for loose hounds during courses in progress.
- 5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
- 6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
- 7. OCRRC assumes no liability for injury to any person or dog before, during or after the Tests and Trials.

DIRECTIONS

From Orange County: Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From the Inland Empire: Take the 91 West onto the 71 North. Exit Butterfield Ranch Road/Euclid Avenue (CA-83) and make a right. The facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From San Gabriel Valley: Take the 210 East to the 57 South. Then, transition on the 71 South towards Corona. Take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit and turn left. The facility will be located on the right side 1/3 of a mile down Euclid Avenue.

PRACTICE

VETERINARIAN

Head south on S Euclid Ave. Turn slight right to merge onto CA-71 S. Keep right at the fork, follow signs for California 91 W/Beach Cities and merge onto CA-91 W. Take exit 39 for Weir Canyon Rd/Yorba Linda Blvd. Turn right onto Yorba Linda Blvd. Take the 1st right onto Savi Ranch Pkwy. Take the 1st left onto Crystal Dr.

HOSPITAL

Head south on S Euclid Ave. Turn left to merge onto CA-71 N. Take exit 7 for Central Ave toward Soquel Canyon Pkwy. Turn right onto Central Ave. Turn right onto Walnut Ave.


BEST IN HOUND CLASSIC
