COURSING ABILITY TEST

300 YARD COURSE: This distance is for dogs shorter than 12 inches at the withers or brachycephalic ("flat-faced") dogs. A dog must complete this course in less than 1 $\frac{1}{2}$ minutes. Veteran dogs (age 7 and older) may run 200 yards.

600 YARD COURSE: This distance is used for all dogs that do not run the 300 yard course. A dog must complete this course in less than 2 minutes. Veteran dogs (age 7 and older) may run 400 yards.

RIBBONS: Orange qualifying ribbons will be awarded to dogs passing their test.

Title medallions will be awarded to dogs completing their CAX.

- 1. Hounds not present at the time of roll call will be scratched after a 5 minute grace period.

- OCRRC assumes no liability for injury to any person or dog before, during or after the Tests and Trials.



DIRECTIONS

From Orange County: Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.


